I agree to the following conditions in order to operate and obtain this booth.

1. Payment for the space leased must be made in full before the booth can be opened for business. Payment for the booth is non-refundable for any reason.
2. The booth will be set up and operable before 12:00 P.M. on each day of the fair and will remain open until 11:00 P.M. for outside and 9:00 P.M. for inside.
3. All deliveries of food and supplies for the booth will be made before 11:00 A.M.
4. The area assigned to me will be kept neat and clean at all times. I will meet any health, safety and sanitation conditions required for the type of booth I have. The Marias Fair will not be responsible for maintenance of any equipment, nor furnish tools to maintain any displays or equipment.
5. Electric service (110v) is available to each space (extension cord will be required in most cases). Any construction, decorating or wiring (must be done by a licensed electrician) is done at the exhibitors expense with the approval of the fair manager or the fair board.
6. I will provide the Marias Fair Board with proof of liability insurance before I can operate my booth.
7. It is expressly understood that the space rented is for my exclusive use and cannot be subleased.
8. Any one selling knives, firearms, or any type of weapon, will be removed from the fairground immediately. They will forfeit any fees paid and will be banned from the Marias Fair.
9. The Marias Fair reserves the right to reject any exhibits or display.
10. I will conduct myself in a courteous and professional manner at all times.
11. The fee paid includes one (1) auto pass. Vehicles may be used to set up and stock the booth, then, all vehicles will be parked in the designated parking lot by 11:00 A.M.
12. Night Security will be patrolling the grounds Thursday, Friday, and Saturday.
13. Tear down of booths may begin after 6:00 P.M. Sunday or first thing Monday morning.
14. No cooking of foods allowed in indoor booths.
